Obviously, this cannot continue long term. It is sometime since the subscriptions have been increased and he suggested that £75 was a more realistic figure to ensure our financial security. Peter Hines suggested that perhaps we should consider holding fund raising

events to assist with the budget.

Speakers: Fraser announced that the speaker programme has been completed up until

the end of November. He also said that the cost of speakers has begun to increase, however he has tried, where possible, to obtain no charge speakers either by club members or from reciprocal speakers from other clubs. He also said that he had spoken to our next speaker who is unable to do his talk via Zoom as he felt it is not compatible to be given virtually. He is going to arrange the services of another speaker and inform the membership

when a speaker has been confirmed.

Theatre Trips: Andrew said that he had looked at possible shows for the Spring, but said

that the cost seems to have increased quite considerably. He felt that we should not attend any event until we feel more comfortable with the Covid

situation.

Outings: David also felt that it was too early to think about organising any outdoor

events at present.
